Any such notice of appeal shall reach the Secretary to the Appeal Tribunal no later than <u>21 days</u> after the date notification of the decision is sent to the person concerned pursuant to section 47 of the Buildings Ordinance.
- (b) The Appeal Tribunal is an independent statutory body and is NOT the Building Authority. It is generally NOT the function of the Appeal Tribunal to handle complaints, enquiries or negotiations regarding the Building Authority; nor to provide advisory, mediation, mitigation or investigation services to the Appellant. If you wish to enquire about the Building Authority's decision/order/notice, please contact the Building Authority (Buildings Department) direct at 2626 1616.
- (c) An appeal to the Appeal Tribunal is a legal action and has legal consequences for the Appellant. Upon dismissal or determination of an appeal, the Appeal Tribunal may order the Appellant or the Respondent (i.e. Building Authority) to bear the costs of the other party to the appeal.

  - (iii) a detailed description of the matter to which the appeal relates;
  - (iv) a description of each document the Appellant intends to produce at the hearing;
  - (v) where relevant, the address and description of any property or land to which the appeal relates and a statement of the interest of the Appellant in that property or land; and
  - (vi) the particulars of the witnesses the Appellant intends to call on his behalf at the hearing.
